

Madison Park HOA –May 12, 2014 Meeting Minutes

Valerie Delby, HOA President, opened the meeting at 7:30 PM and welcomed everyone in attendance.

Officer Mohammad also shared with the community that there had been **5 burglaries reported on May 12 with locations in or around Murray Hill and Seneca Place**. CMPD has increased their patrols of the neighborhood and will continue with their pursuit of leads regarding possible suspects.

CMPD stated to be sure to keep blind, shades and curtains closed at night as well as to secure your outdoor sheds and electrical boxes to help avoid crime. He also advised to keep the shrubs around your home trimmed and know your neighbors; if something looks suspicious, **CALL 911**; better to be safe than sorry. The police would rather come out and investigate so the bad guys can be caught.

It was advised by CMPD at a previous HOA meeting that residents should keep an inventory of their electronics, jewelry and other personal items (including serial numbers where applicable). Pictures and serial numbers help the police find stolen items faster especially when they are pawned so be sure to take an inventory and keep it in a safe location.

"Park on Montford" mixed use proposed development

City rezoning meeting was held May 5th as a first step to determine how the potential mixed use development may be constructed. Members from the HOA and neighborhood attended the meeting and Kevin Nunnery, resident on Drexmore, was on hand to provide an update on the meeting as well as the neighbors next steps.

Kevin shared that the primary concern is around increased traffic and property values in the neighborhood specifically on Drexmore. This concern, along with many other such as

building height, parking and whether the facility will be apartments or condos were presented by the neighborhood attendees. Kevin along with other resident on Drexmore has yard signs that are on display in protest to the current developments plans. For information regarding signage please contact Kevin at kunnery@st-peters.org. **Reminder** – any signage must be placed in a residents yard and at least 11 feet from the curb otherwise it is considered a City Code violation.

Note - A Community Meeting will be held May 20th at 7:00 pm at Park Road Baptist Church (in the former Chapel) located at 3900 Park Road. The meeting will be lead by Selwyn Partners Group as an update to the community following their feedback from the city on their revised development plans and elevation.

A meeting between Pinewood Elementary, Char-Meck Neighborhood Matching Grant (NMG) program and Madison Park on May 1 to determine next steps for project planning. Based on the discussion, it was decided that the allocated funds will be spread across the Extended Learning program and Joint Marketing Planning for next school year.
