Presidents Report

- Madison Park HOA has received approval for a \$7,916 Neighborhood Matching Grant. Moneys from this grant will be used to improve joint communication efforts by the HOA and Pinewood Elementary. The grant was signed off on April 9th. We have one year to spend the money.
- Repairs to the Madison Central Park Sign are currently in progress. The board is working on a long-term strategy for managing future maintenance-related expenses. The sign should be repaired and reinstalled within the next two weeks.
- About thirty-ish big and little people showed up for the Third Annual Easter Egg Hunt in Madison Central Park. Special thanks to Carly Baker for being an uber-volunteer for the event.
- Pinewood Partners meeting is April 16th. Includes school personnel, HOA and other community organizations.
- Park Road Shopping Center has petitioned for rezoning of the old Monkey Joe's space, which fronts Woodlawn Road. (2015-57). I have reached out to PRSC to see if we can have someone come out and talk at an HOA meeting. I haven't gotten any feedback yet.
- Margaret and I attended the Neighborhood Matching Grant orientation meeting on March 12.
- Charlotte-Mecklenburg Schools is taking the first steps in a wholesale review of how it assigns students to schools, and everything will be on the table – from school boundaries to the rules for the magnet lottery. The HOA is specifically working on requesting a change to our middle school and high school assignments for our neighborhood. These requested changes could increase our home values by the sheer fact that we would be in a "more desirable" school district. Let your voices be heard and help us to hopefully get the boundaries changed.
- Hard copies of the March meeting Minutes were made available in the Little Free Library on Gentry Place. This will continue as long as copies are being taken and read.

Speakers

Joe Frey, Cross Charlotte Trail

This is a 26 mile trail from Pineville to Cabarrus County that will allow users to bike / hike across the county in an area separated from vehicular traffic. Currently there are 7.6 existing trail miles of the Cross Charlotte Trail; the county will complete 5.5 miles of the trail and the city to complete 12.8 miles for a total of 25.9 miles. It will be more than JUST a place to walk...it becomes a Transportation System. Access to trails ranked as second most important community amenity and effects transportation, economic development, property values and quality of life. This trail will also create Economic Development around it by drawing businesses to the area. People want to live close to trails, businesses move close to where the talent that resides there. Currently Charlotte is the 16th most populous city in the US and ranks 36th for the miles of trail we have (including the 26 miles of Cross Charlotte Trail). There are 80,000 residents and 98,000 jobs located within ½ mile radius of the trail. The #1 priority is to complete the section between Brandywine and Tyvola within 5 years. Funding will come from street bonds with voters deciding. The

schedule for construction would be conceptual design / modeling to be complete by Fall 2015; real estate acquisitions to be complete by Spring 2017; Final design / permitting through 2016 and bidding and construction to happen 2017 -2019 if funded by Public Improvement Bonds in 2016. This trail will become part of the Carolina Thread Trails system. Mike Davis, CDOT, Developmental Services Division Manager

Mike explained that his job is to look at the whole impact of redevelopment in an area (not just one project; but multiple ones). Charlotte Department of Transportation's key goal isConnecting Charlotte. CDOT is committed to enhancing the driving, bicycling and walking experience through planning, operating and maintaining the City's transportation choices for residents and visitors. An important objective is to sustain, maintain and enhance the City's transportation infrastructure. CharMeck Metropolitan area ranks 20th in US populations and 21st in congestion. The city / county is focusing on transportation corridors (i.e. South Boulevard Corridor) and mixed use activity centers (i.e. Southpark and Park Road areas). The millennials are not necessarily interested in getting in a car to access amenities. They want more walkable, bikeable areas so growth happens around activity centers. The goal is to make every rezoning fit the puzzle better.....being safer with better connectivity. There is more interest in infield development instead of going farther outside of the city to create new areas of development.
